



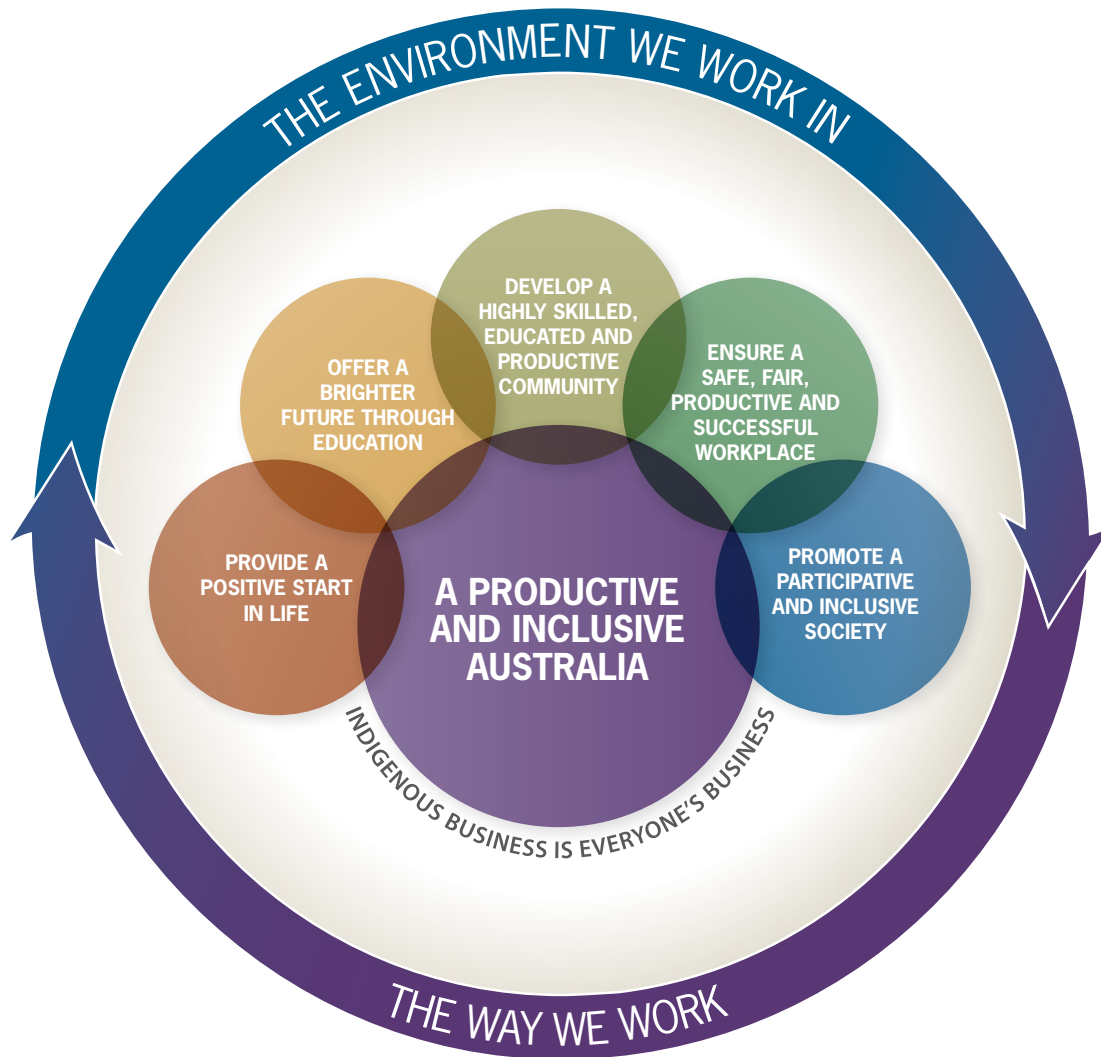
DEEWR mission

The work we do

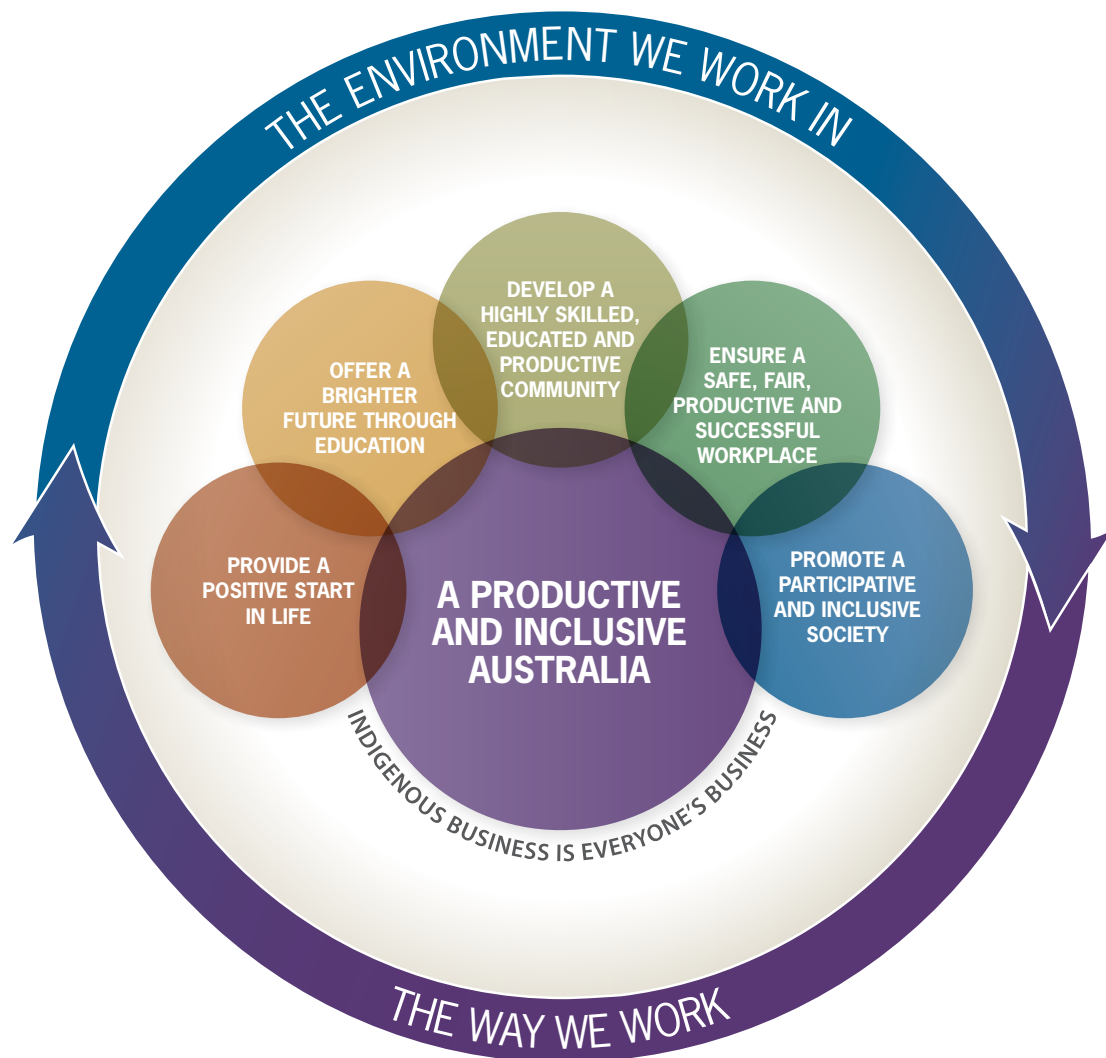

Children have access to culturally appropriate support, care and education throughout early childhood that will equip them for life and learning.

- Continue to implement and promote the Early Childhood Development Strategy as the overarching policy framework for early childhood development in Australia.
- Implement agreed national standards through the National Quality Framework for Early childhood education and care, and invest in programs and infrastructure to improve access to quality early childhood learning and child care services.
- Develop a workforce strategy to increase the supply and improve the quality of teaching and care in early childhood across all settings.
- Assist parents and carers to access affordable child care and support them in their key roles as early childhood educators and carers.
- Continue to lead the action on the Early Childhood Closing the Gap target by implementing policies and strategies to improve the access to quality early childhood education and care services for Aboriginal and Torres Strait Islander children and their families.

Develop a highly skilled, educated and productive community

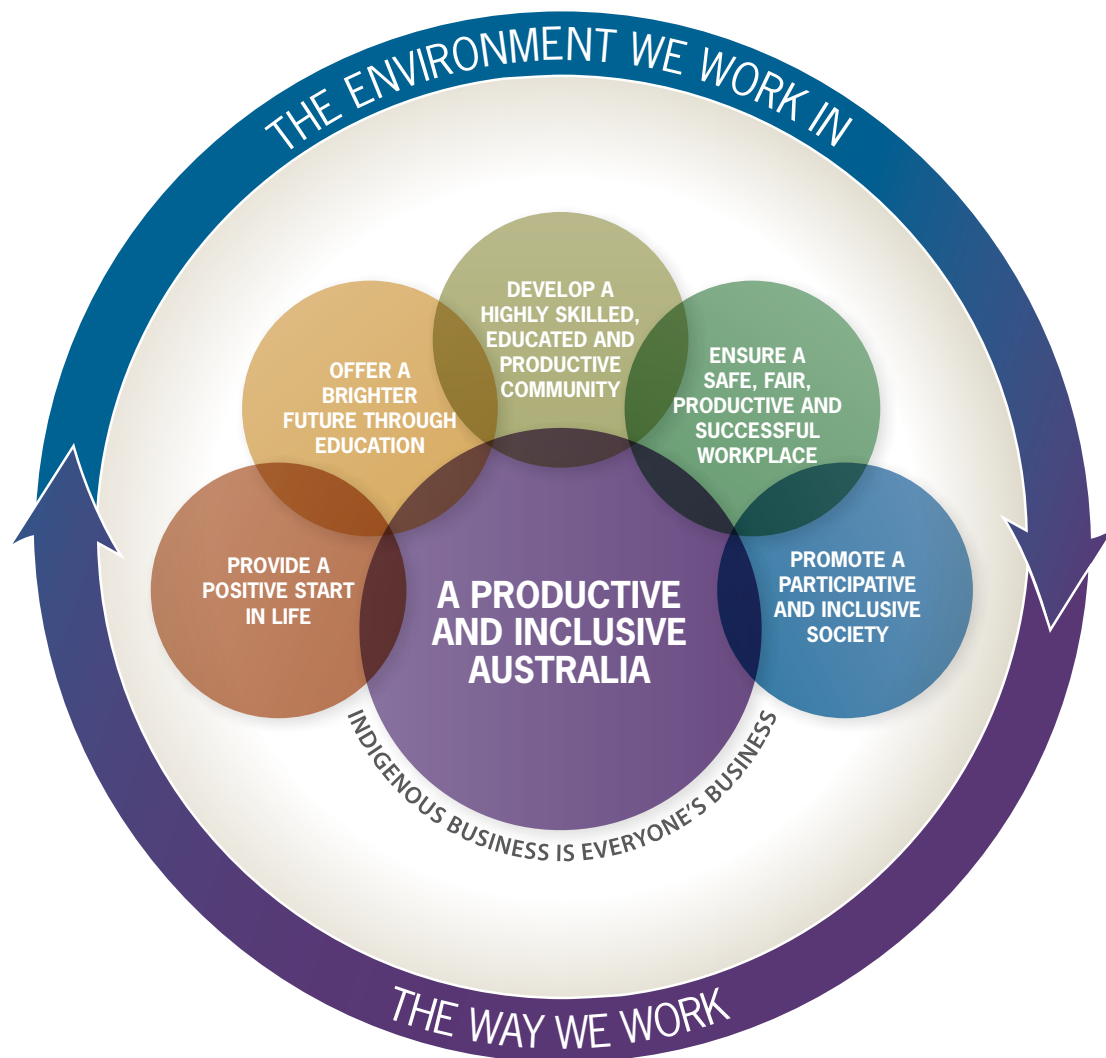
Through world class higher education and vocational education and training, people can achieve their full potential and become productive participants in the modern labour market.

Our corporate and enabling groups provide core services and support the business areas to deliver on the department's goals. Their work includes building the future capability and ensuring the reputation and accountability of the department.

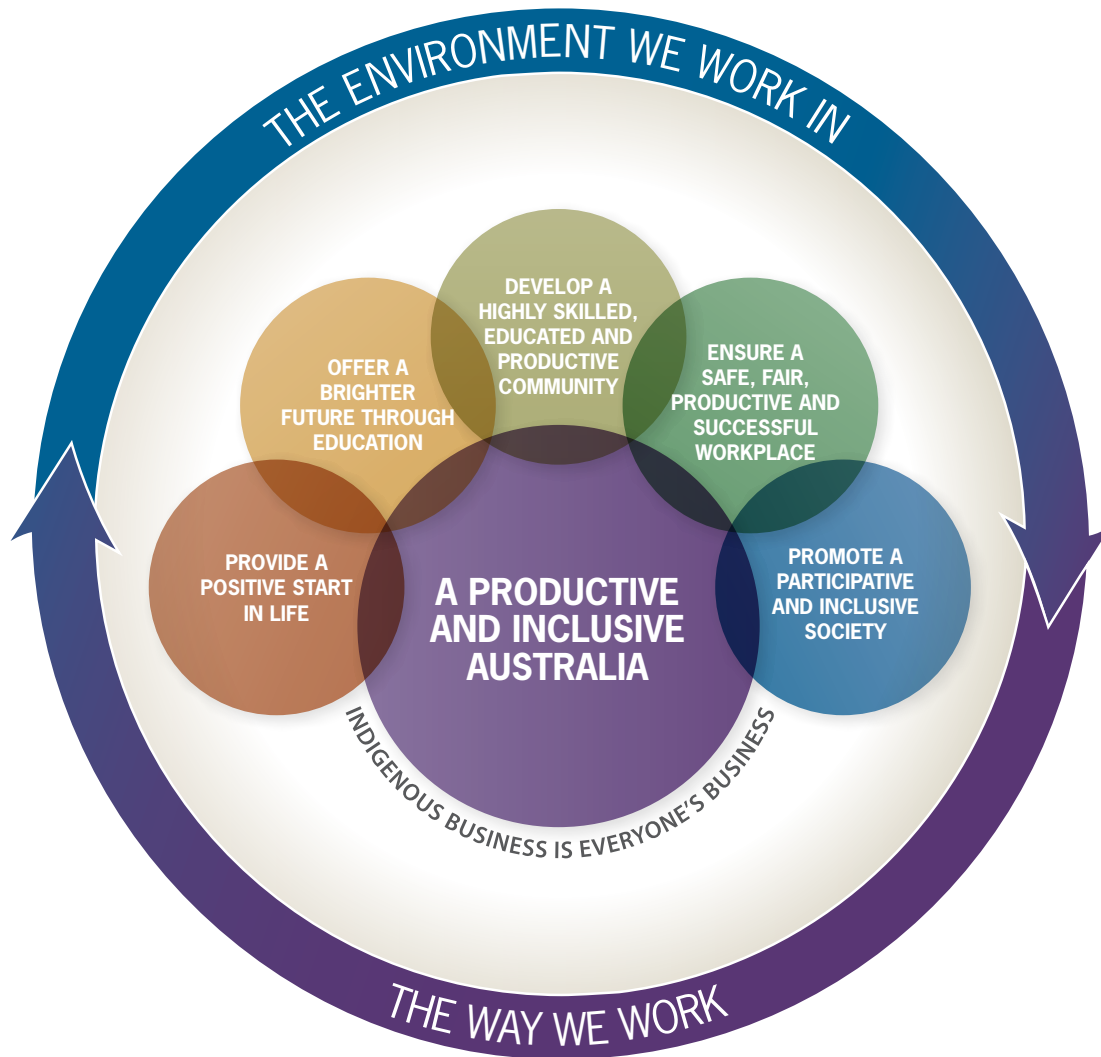
These groups support the department to

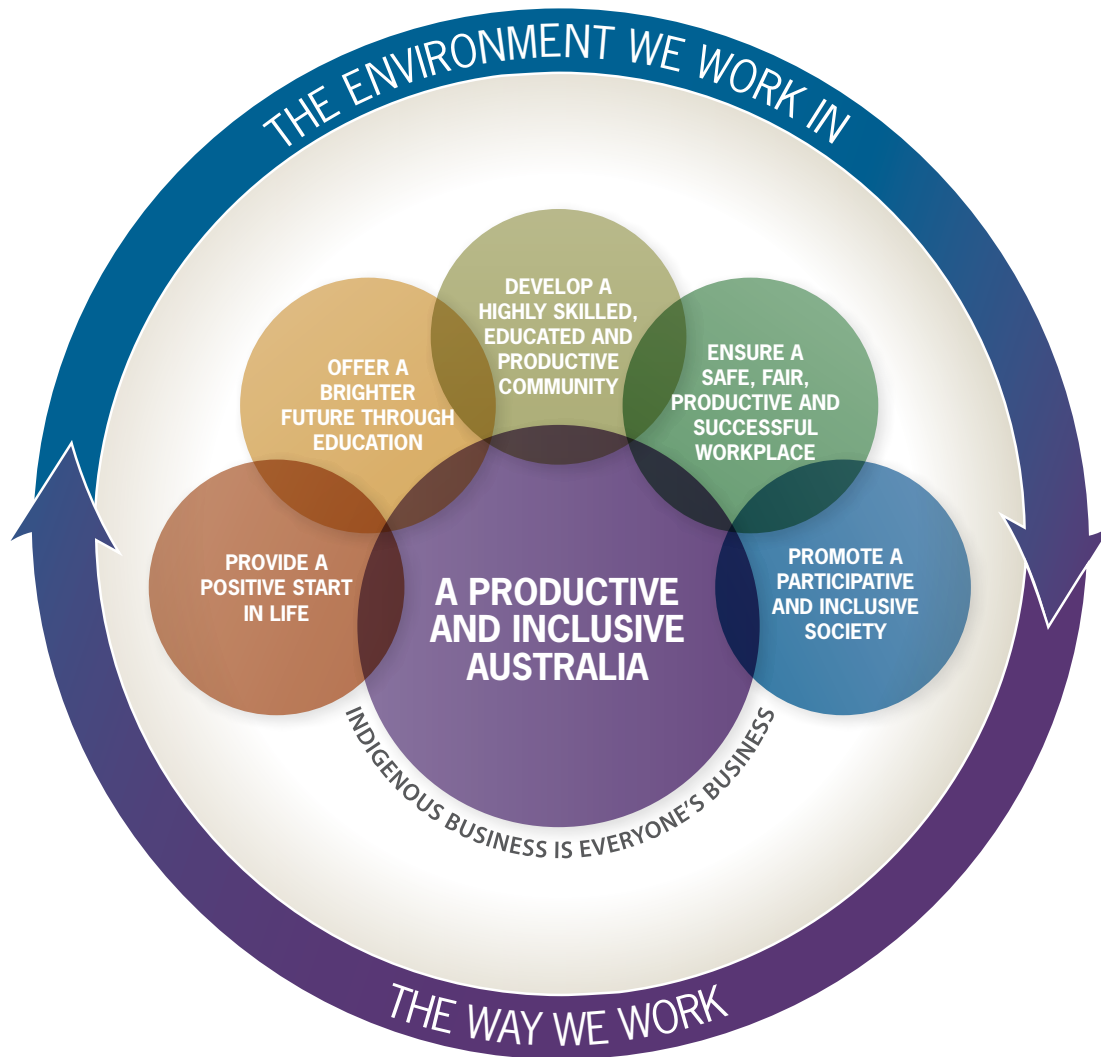

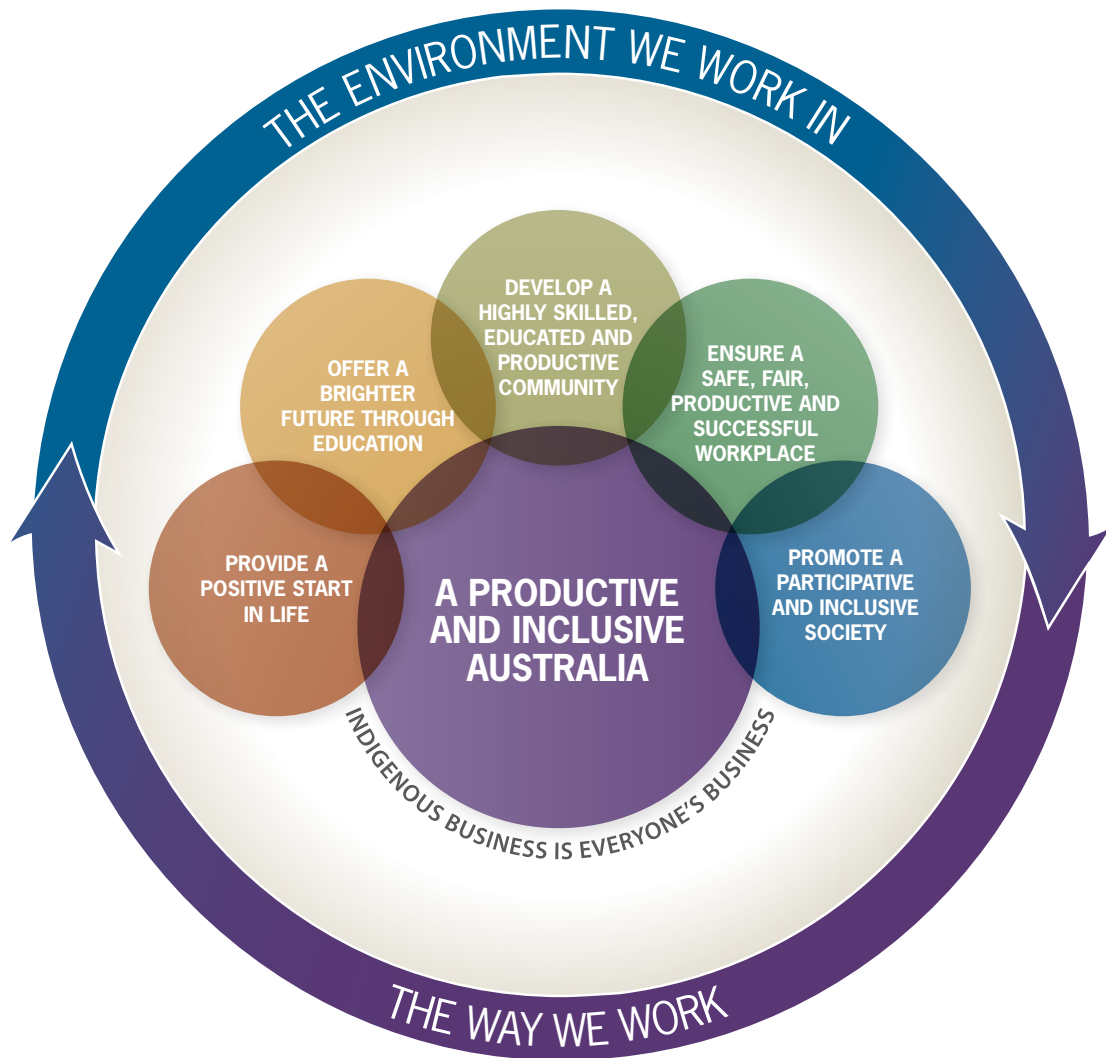
The DEEWR governance structure provides for efficient and effective decision making and meets better practice standards. This is supported by:

Closing the Gap

In December 2007 the Council of Australian Governments agreed to a partnership between all levels of government to work with Indigenous communities to achieve the target of closing the gap in Indigenous disadvantage.

DEEWR has lead responsibility for four of the six Closing the Gap targets. The department implements policies and programs towards achieving these targets. They are:

- ensure access to early childhood education for all Indigenous four years olds in remote communities within five years
- halve the gap in reading, writing and numeracy achievements for children within a decade
- halve the gap for Indigenous students in Year 12 (or equivalent) attainment rates by 2020
- halve the gap in employment outcomes between Indigenous and non-Indigenous Australians within a decade.

Aboriginal and Torres Strait Islander peoples are an integral part of our business and workforce; together we contribute to a productive and inclusive Australia through our commitment to reconciliation.
